# MINUTES OF THE NASHVILLE PLANNING BOARD TUESDAY, OCTOBER 31, 2023

#### 1. CALL TO ORDER AND ROLL CALL: 6:00pm

The Nashville Planning Board held its monthly meeting on Tuesday, October 31, 2023 in the Town Council Chambers at 114 W. Church Street at approximately 6:00PM. Chairman Bill Lumpp recognized a quorum and called the meeting to order.

#### 2. MINUTES OF THE PRECEDING MEETING: September 26, 2023

The minutes of the preceding meeting listed above were reviewed. The minutes were motioned to be approved by Board Member Jacquelyn Lewis and seconded by Board Member Ann Collier; there was no further discussion; the motion unanimously passed 6-0.

#### 3. NEW BUSINESS (AGENDA-STAFF REPORT ATTACHED):

Chairman Bill Lumpp introduced the item.

**FP: 2023-02:** Consideration of a Final Plat – Cardinal Woods Subdivision – Phase 1; located off Glover Park Memorial Drive; there are approximately 116 proposed lots; 50.04+/-acres; Nash County PIN# 3800 1674 5123; zoned MF (Multi-Family) and R-10 (Medium Density Residential).

Planning Director Sherry Moss presented a summary of the item to the Planning Board.

She stated that this is a final plat and reiterated that the construction plat came before the Planning Board back in 2021. She mentioned that the construction plat approval by Town Council was located in the last two or three pages of the packet. Ms. Moss informed the board that this final is just for phase one for 116 Lots, the original plan was for 246 Lots. She also pointed out that the developers were present to answer any questions or concerns that the board may have regarding development. She also stated that the purpose of the final

plat is to review any changes, if any, from the construction plant layout to the final plat layout and added thus far everything is pretty much the same.

The public hearing was opened and the cemetery with a barrier within the subdivision was questioned.

Bob Mishler and Lauren Granger from Ashton Woods were present to speak on behalf of the development of Cardinal Woods Subdivision. With regards to the cemetery, Mr. Mishler responded that they will keep it cleaned up and added that a black aluminum fence with wire rolled arms will be around the cemetery and an easement maintained by the HOA.

The intent of extending Essex Road was then questioned.

Lauren Granger replied that Essex Road will be extended into the community. For a couple of reasons, 1) there will be extra connectivity through the neighborhood and 2) the biggest reason, is at 100 lots, a second point of access is needed. Ms. Granger stated the intention is to keep Essex Road closed until the 100-lot threshold is reached unless the town directs to open it up sooner.

A question was raised whether the residents were aware of this.

Bob Mishler replied yes and added he'd been here since the beginning of this project and met with quite a few of the neighbors and they do know about the connection. He stated the neighbors were told at that time that it would be closed off, as long as they could with the expectancy of 100 certificates of occupancy, then they would have to open it up.

The neighbor's response was that they did not like the condition of the asphalt on Essex. Mr. Mishler was concerned about that. He stated his understanding was, the town had come up with some type of plan to resurface that.

The neighbor's concerns of the through traffic was also questioned.

Mr. Mishler stated that the neighbors did not want any traffic whatsoever, but they understood the connectivity and safety reasons. He added the neighbors were in agreement when it was all said and done and that they (Ashton Woods) would do what they needed to do and added that he believed the town made an agreement also at the same time that they (the Town) would repair or overlay that street. And at that point the neighbors were fine with that. A public hearing was held and they had an opportunity to speak.

Mr. Mishler informed the Planning Board that they are stubbing streets to undeveloped properties. Typically, they would leave barriers there and a sign that says future road connection, so the neighbors know what's coming.

Mr. Mishler added they had some pretty good and lively discussions here and out in the parking lot as well and got some phone calls in his office. He mentioned they were very transparent about what they had planned to do. He stated he thinks the biggest thing was not just the amount of traffic. It was the fact that there was traffic on the road, and they didn't like the condition of the roads. Mr. Mishler added that was resolved by the town agreeing to take care of that.

Ms. Moss reiterated that proper measures have been put in place for the concern with the school on how they directed their traffic and with the traffic study. The right turn lane of 58 was put in and is now completed.

Ms. Moss also reported to the board that town staff have monthly meetings with Ashton Woods and Wynn Construction on a monthly basis for updates. This includes all the people that's working out in the field, our police, fire representative Town Manager, Planning Director, and NCDOT, etc.

A question was raised regarding every street having a sidewalk. Ms. Moss confirmed yes.

There was a brief discussion regarding the sidewalk going all the way around the cul-de-sac or stopping.

There were no further questions for planning staff or Ashton Woods.

5. ADJOURNMENT

The public hearing was closed, and Chairman Bill Lumpp called for a motion. Board Member Wayne Sears motioned to approve the Cardinal Woods final plat. Board Member Ann Collier seconded the motion. There was no further discussion. The motion unanimously passed 6-0.

**4. ANNOUNCEMENT OF NEXT MEETING:** November 28, 2023, at 6pm Ms. Moss informed the board that the next meeting will be held on November 28, 2023, pending if any items come in.
